Aditya Pratap Deo, former Fellow of Indian Institute of Advanced Study, Shimla, is Associate Professor in History at St Stephen's College, Delhi. He works on the history of tribal peoples, state formation and central India, and anthropological history and philosophy of history. He has published on all these themes and his book *Kings, Spirits and Memory in Central India: Enchanting the State* was released by Routledge, London, in 2021.

He works on Northeast India and its neighbourhood; and his current research is transboundary environmental governance from the perspective of international relations with an emphasis on Northeast India and the greater Eastern Himalayan region.

Gita Dharampal, former chair of the South Asia Institute, Heidelberg University, is Honorary Research Dean at the Gandhi Research Foundation, Jalgaon, Maharashtra. Her research foci deal with topics ranging from pre-modern transcultural interactions between

Europe and India, the maritime cultural history of the Indian Ocean region (700-1700), medical history, religious-ritual transformations, the socio-cultural and political history of the colonial period, with a special emphasis on Gandhi's movement for political and cultural resurgence, for which she directed an ICSSR major research project (2020-22). Her publications (comprising articles and books in French, German, and English) deal with all the above topics.

Kasmita Bora is Assistant Professor in the Department of Political Science, Bhattadev University, Assam; and doctoral scholar in the Department of Political Science, Cotton University, Assam. Her current research is titled 'Political Ecology and Extraction of Natural Resources in India's Northeast Frontier'.

She has written four books: *D.H.
